Good morning Morgan,

Hope this email finds you well.

Please find attached a poster of the upcoming implementation of Registered Nurses Association of Ontario (RNAO) Clinical Pathways on Admission Assessment, Delirium and Resident and Family Centred Care. These are three new Best Practice Guidelines that Chester Village will be implementing to have a better resident centred care. We have started the preparations since November 2023 and we are now completing the training of all concerned staff. This is the first 3 of 7 clinical pathways that we are implementing in a span of 3 years and we will go live on February 29-2024. All these assessments are imbedded in our documentation software.

The change that residents and families may find different for new admissions will be that, the staff will pend more time with resident and /or family on admission. The staff will ask more resident centred focus questions for us to get to know the resident very well and be able to complete a care plan within 24H that is more reflective of the needs and wishes of the resident.
